## Wendell Potter and Michael Moore Speak Up For Temple Strikers



Health Insurance whistleblower, Wendell Potter, addressed the importance of speaking out for patients

Monday at 5:30pm outside Temple Hospital, hundreds of striking nurses and healthcare professionals rallied once again rally to urge Temple return to the bargaining table to negotiate openly and fairly on all the issues. Speakers included nurse and union leaders as well as Wendell Potter, former executive of Cigna Healthcare. A letter from Michael Moore, director of "SiCKO," was also presented during the rally.

Wendell Potter addressed the issue of speaking up for patients. Similar to the nurses' position that Temple should put "patients before profits," Potter has testified and spoken in numerous public settings about the intrusion of greed into healthcare and its impact on reducing access to care.

"We are thrilled that Potter came to speak to all of us who are out on strike in a fight for our patients and our professions. The patients we serve deserve the best possible care and we need to see improvements in our hospital, but Temple has both refused to negotiate patient safety issues such as safe staffing and has sought to keep us publicly silent ...
